SUBJECT: SUMMARY OF SITE VISITS TO ALTERNATIVE SITES TO THE EGC ESP SITE
IN CLINTON, ILLINOIS

From March 1 through March 11, 2004, representatives of the U.S. Nuclear Regulatory Commission (NRC) staff and contractors from Pacific Northwest National Laboratory (PNNL) conducted site visits to those sites identified by the Exelon Generation Company, LLC (EGC or Exelon) as potential alternative sites to the EGC Early Site Permit (ESP) site located in Clinton, Illinois. The goal of the site visits was to obtain a general idea of the layout of the site; what water resources, wetlands, and important habitats exist at the sites; what cultural resources exist at the sites; what socioeconomic conditions exist in the vicinity of the sites; and what impediments exist for adding an additional facility on the sites.

The NRC opened each meeting with a brief explanation that the goal of the alternative site review is to determine whether any of the proposed alternative sites are obviously superior to the EGC ESP site at Clinton, Illinois in terms of environmental impacts and economic costs. To make this determination, the staff performs a high-level assessment of what the environmental consequences of constructing and operating a new nuclear facility at the alternative sites could be using reconnaissance-level information. The purpose of the site visit was to obtain an understanding of the general layout of the site to better understand the reconnaissance-level information the staff was using during its review.

At each site, Exelon provided a brief overview of the layout of the plant and answered staff questions concerning the site and environs, which was then followed by a guided automobile tour of the site, focusing on areas relevant to the environmental review. Enclosure 1 is the list of NRC, PNNL, and Exelon representatives that participated in the site visits.

In addition, during the visit to the Zion site, Exelon made a presentation to clarify the process used by the applicant to assess the six alternative sites against the EGC ESP site. As a result of the discussion, Exelon developed the enclosed white paper (Enclosure 2) to clarify this process. Attachment 1 to the enclosure illustrates the alternative site comparison process.
