TIMELY PNOTIFICATION TO NRC STAFF OF
NWB and ASSOCIATED MEETINGS

SUMMARY

I received a copy of the September 22-26, 1986 meeting package of the Hanford Health Effects Panel ^(HHEP) on October 7, 1986. Upon reviewing the package and the attendant file, I found that, to the best of my knowledge, NRC had not received a notification of this meeting. I called Mr. Warren Bishop, Chairman of the NWB, and conveyed to him NRC's interest in Washington's Nuclear Waste Program and concerns, and that we would appreciate any prenotification of nuclear waste-related meetings. Mr. Bishop seemed upset that we had not received a notification of the HHEP meeting, and I emphasized that it could have gotten lost in transit. He apologized and invited me to attend the Oct. 16-17, 1986 meeting of the NWB. He said that the results of the HHEP meeting will be reviewed and discussed on Oct. 16, and the NWB and Advisory Council will have a regular meeting on Oct. 17. He took my name and address so that I will receive future notifications of pertinent meetings. Mr. Bishop also mentioned that Referendum 40 (?) would be on the November ballot, and that the NWB planned to conduct 5 information-only public meetings throughout Washington State concerning Referendum 40.
