The purpose of this modification is to (1) increase the amount funded in the delivery order by \$410,000.00, from \$1,184,240.00 to \$1,594,240.00, and (2) change the Contracting Officer from Sally A. Adams to Carolyn A. Cooper. Accordingly, the delivery order is hereby modified:

(1) Section B, Consideration and Obligation, fourth paragraph, first sentence, as modified in Modification 4, is deleted and replaced with the following in lieu thereof:

"The amount presently obligated with respect to this order is \$1,594,240.00."

Section B, Consideration and Obligation, fifth paragraph, as modified in Modification No. 4, is deleted and replaced with the following in lieu thereof:

"It is estimated that the amount currently allotted will cover performance of the effort through August 31, 2004."

(2) Under Section C.7.c, Statement of Work, Place of Delivery-Reports, delete "Sally Adams, Contracting Officer" and replace with "Carolyn A. Cooper, Contracting Officer."

This modification obligates fiscal year 2004 funds in the amount of \$410,000.00.

A summary of obligations from the date of award through the date of this action is provided as follows:

FY 2004 OBLIGATIONS:	\$ 610,000.00

All other terms and conditions of the subject delivery order remain unchanged, including the ceiling amount of \$2,129,596.46.
