Dear Chairman Pallidino:

As you are aware, the state of Utah is currently under consideration for the siting of a nuclear waste repository. The Gibson Dome site in the Paradox Basin is a bedded salt site which is located less than a mile from the boundary of the Canyonlands National Park and eleven miles from the Colorado River. It is an extraordinarily complex terrain as well as one of great scenic value. Needless to say, the public opposition to continued DOE activities in the area has been resounding.

It has recently come to my attention that the DOE has engaged in informal negotiations with the Nuclear Regulatory Commission to allow relaxation of the 10 C.F.R. 60 regulations. Specifically, I have learned that DOE has requested the NRC to relax or modify the requirement that three sites be fully characterized prior to selection of the final site for a repository; that the requirement for an exploratory shaft in salt be eliminated (or a decision made at this point not to require an exploratory shaft in salt); and that authorization be granted to begin construction of a repository prior to completion of licensing procedures. It is my understanding the pre-licensing work authorization is being requested for 1985 with construction to begin in 1986.

Inasmuch as the preliminary engineering work is completed on the Utah Gibson Dome site, and a model of a repository, with attendant rail, power, and water access routes through the complex geographic terrain is available for public review, I have considerable concern that any informal




