INSTALLATION

Dear Mr. Pietruzka:

The U.S. Nuclear Regulatory Commission (NRC) staff is currently reviewing an application originally submitted by the General Electric Company on May 22, 2000, for renewal of Materials License SNM-2500 for the General Electric Morris Operation (GE-MO) Independent Spent Fuel Storage Installation (ISFSI) on the Morris Operation site in Grundy County, Illinois. An applicant for a license renewal of this type must submit an environmental report as part of its application, as required under 10 CFR Part 51 of the NRC's regulations. The NRC staff reviews this information in accordance with the requirements of the National Environmental Policy Act, as specified in 10 CFR 51.10.

The NRC staff has completed its environmental review of GE-MO's application, and we have drafted an Environmental Assessment (EA) to document our findings. We conclude in the EA that the proposed action will not significantly affect the quality of the human environment.

Consistent with NRC policy for such actions, the staff is contacting you and the designated representatives of the Office of the Governor and the Illinois Historic Preservation Agency to ensure an opportunity to comment on environmental issues prior to public issuance of the EA. Ms. Kristen Richards and Mr. William Wheeler of the aforementioned State of Illinois offices have been contacted. Copies of the NRC staff's draft EA have been forwarded to them for review and comment. To ensure that the State of Illinois has been comprehensively afforded an opportunity to review and comment on the draft EA, I have enclosed a copy, which is marked as pre-decisional information, for your review and comment. We request that the distribution and use of this document be limited only to those staff involved in the review and comment process. We further request that your office provide any comments to the NRC staff within 30 days of receipt of this letter.
