EXTRACT OF MINUTES OF THE BOARD OF TRUSTEES OF THE VILLAGE OF MAMARONECK HELD ON MONDAY, MARCH 22, 2004, AT 7:00 P.M. IN THE COURTROOM AT VILLAGE HALL, 169 MOUNT PLEASANT AVENUE, MAMARONECK, NEW YORK.

PROPOSED RESOLUTION – INDIAN POINT NUCLEAR POWER PLANT

On motion of Trustee Derrico, seconded by Trustee Vozza:

WHEREAS, Entergy Corp., owner and operator of the Indian Point Nuclear Power Plants, has expressed its intent to apply for operating license extensions of 20 years for Indian Point 2 (IP2) and Indian Point 3 (IP3), and being that the Village of Mamaroneck Board of Trustees has previously expressed its concern over the continued operation of the nuclear power plants at the Indian Point Energy Center through several resolutions passed by this Board, which calls on officials from the Federal, State and Local governments to work with relevant parties to develop a plan that includes the below listed action steps, namely:

1. the development of an alternative, uninterrupted, and affordable energy source to replace the power currently produced at Indian Point,
2. the development of a financial plan that will mitigate the negative real estate tax implications on the local communities, school district, and county government,
3. the development of a plan to positively consider the current employees, such consideration will include job placement, retraining of affected workers, and other employment strategies, and
4. the development of a plan that ensures that spent fuel rods will be immediately secured and properly protected on site from the threat of a terrorist attack or accident, and that an orderly closure and decommissioning of the Indian Point Power Plants begin at the earliest possible time, and

WHEREAS, the Board of Trustees of the Village of Mamaroneck reiterates its resolve, based on the potential of a terror attack on the plants, a concern about the age of the plants, and the potential results of a failure of equipment or human error in the operation of the plants, and

WHEREAS, Indian Point 2 and 3 were initially licensed based on Nuclear Regulatory Commission (NRC) regulations promulgated over 30 years ago, and if plant owners were to apply for a license to operate a nuclear power plant at the Indian Point site today, it would not likely be granted by the NRC under its current standards and regulations, specifically prohibiting the siting of nuclear power plants based on population density considerations;

NOW, THEREFORE, BE IT RESOLVED, that the Board of Trustees of the Village of Mamaroneck opposes the re-licensing of Indian Point 2 and Indian Point 3 when their current licenses expire in 2013 and 2015, respectively, and that the NRC prohibit Entergy Corp.'s Indian Point 2 and 3 from being re-licensed, and to make this finding as soon as possible so that all concerned and involved parties can devote their time and resources to finding alternatives to the existing nuclear power plants, and

BE IT FURTHER RESOLVED, that the NRC should modify, through its GEIS process, its siting regulations to reflect current considerations including that of terrorism, and

BE IT FURTHER RESOLVED, that the Village Clerk forward the text of this resolution to Westchester County's State and Federal delegation, to all legislative bodies and elected officials within the 50-mile zone surrounding the Indian Point Nuclear Power Plants, the Nuclear Regulatory Commission and Entergy Corp., so that the intent of the Board of Trustees of the Village of Mamaroneck is widely known.



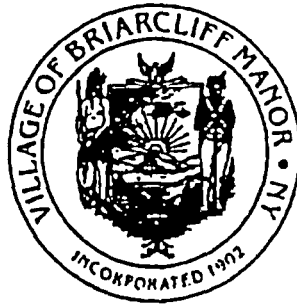

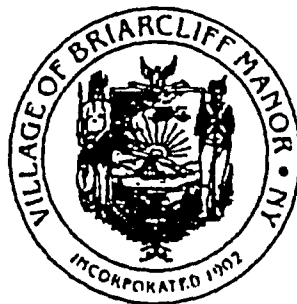

Indian Point Resolution

WHEREAS, Entergy Corp., owner and operator of the Indian Point Nuclear Power Plants, has expressed its intent to apply for operating license extensions of twenty (20) years for Indian Point 2 and Indian Point 3; and

WHEREAS, the Board of Trustees adopted resolutions on both January 16, 2003 and December 6, 2001 concerning security of the plant facility; safety of the residents, businesses and other institutions in the immediate area and within fifty miles of the plant; the evacuation plans, taking into consideration the increase in development in and around the evacuation routes; the possibility of the plant being a target of terrorism; the storage of spent fuel rods; and the utilization of alternative fuel sources.

WHEREAS, the Westchester County Board of Legislators adopted Resolution No. 142-2002, which calls on officials from the Federal, State and Local governments to work with relevant parties to develop a plan that includes the below listed action steps, namely:

1. The development of an alternative, uninterrupted, and affordable energy source to replace the power currently produced at Indian Point.
2. The development of a financial plan that will mitigate the negative real estate tax implications on the local communities, school district, and county government.
3. The development of a plan to positively consider the current employees, such consideration will include job placement, retraining of affected workers, and other employment strategies, and
4. The development of a plan that ensures that spent fuel rods will be immediately Secured and properly protected on site from the threat of a terrorist attack or accident, and that an orderly closure and decommissioning of the Indian Point Nuclear Power Plants begin at the earliest possible time, and

WHEREAS, the Board of Trustees concurs with the content of Westchester County Board of Legislators Resolution No. 142-2002, adding to Clause 1 the following additional language:

The development of an alternative, uninterrupted, and affordable energy source to replace the power currently produced at Indian Point, provided that the alternative, uninterrupted, and affordable energy source does not pose a health or

safety risk to the residents of the Village of Briarcliff Manor or Westchester County; and

WHEREAS, the Board of Trustees concurs with the content of Westchester County Board of Legislators Resolution No. 142-2002, based on the potential of a terror attack on the plants, a concern about the age of the plants, and the potential results of a failure of equipment or human error in the operations of the plants; and

WHEREAS, Indian Point 2 and 3 were initially licensed based on Nuclear Regulatory Commission (NRC) regulations promulgated over 30 years ago, and if plant owners were to apply for a license to operate a nuclear power plant at the Indian Point site today, it would not likely be granted by the NRC under its current standards and regulations, specifically prohibiting the siting of nuclear power plants based on population density considerations.

BE IT FURTHER RESOLVED, that the Village Clerk forward the text of this resolution to Westchester County's State and Federal delegation, to all legislative bodies and elected officials within Westchester County, the Nuclear Regulatory Commission and Entergy Corp., so that the intent of this Board of Trustees be widely known.
