


The purpose of this modification is to: 1) Change the number of the BPA order from NRC-33-03-344-003 to NRC-33-03-354-001, 2) Extend the period of performance of the order from March 31, 2004 through August 31, 2004, at no extra cost to the Government, 3) Exercise Optional Tasks 6 and 7 of the order, and 4) Increase the ceiling and obligated amounts of the order by \$34,575.70, from \$62,674.00 to \$97,249.70 to allow for the optional tasks. Accordingly, the contract is hereby modified:

1) Optional Form 347, Order for Supplies or Services, Block 3, is deleted and substituted with the following in lieu thereof:

All future documents relating to this order shall refer to this order number, including invoices submitted for payment.

2) Optional Form 347, Order for Supplies or Services, Block 17, second paragraph, beginning with "The total estimated . . ." is deleted and substituted with the following in lieu thereof:

"The Government hereby exercises Optional Tasks 6 and 7 to this order. The total estimated ceiling amount of this order is \$97,249.70. The total amount obligated with respect to this order is 97,249.70."

3) Optional Form 347, Order for Supplies or Services, Block 17, third paragraph, beginning with the "The order period . . ." is deleted and substituted with the following in lieu thereof:

"The order period of this order shall commence on October 1, 2003 and will expire on August 31, 2004."
