SUBJECT: SUMMARY OF THE APRIL 8, 2004, PUBLIC MEETINGS TO DISCUSS
LICENSEE PERFORMANCE AND PLANNED ACTIVITIES AS PART OF THE
MANUAL CHAPTER 0350 PROCESS AT THE DAVIS-BESSE NUCLEAR
POWER STATION

On April 8, 2004, the Nuclear Regulatory Commission (NRC) held two public meetings at the Oak Harbor High School in Oak Harbor, Ohio. The first meeting was between the NRC Davis-Besse Oversight Panel and FirstEnergy Nuclear Operating Company (FENOC) to discuss licensee performance and planned activities as part of the Manual Chapter 0350 process at the Davis-Besse Nuclear Power Station. The letter of notification, meeting notice, NRC presentation, and licensee presentation can be found in ADAMS as ML040840626, ML040840628, ML041040069, and ML041050604, respectively. The transcript of the meeting will be made publicly available in ADAMS and on the NRC's Davis-Besse web page when it is available. A list of NRC and licensee meeting participants can be found in the attached Enclosure. This was the first public meeting held between the Oversight Panel and the licensee since restart of the facility was approved on March 8, 2004. Agenda topics included, milestones between restart approval and 100% reactor power, assessment of plant performance, highlights of the licensee's Cycle 14 Operational Improvement Plan, and licensee's plans to implement the Confirmatory Order.

The second meeting was between the NRC and members of the public. During the meeting, the NRC summarized the discussion from the earlier meeting between the NRC and FENOC and then provided time for public questions and comments. The meeting notice and NRC agenda can be found in ADAMS as ML040840629 and ML041040069, respectively.
