I SECY-78-497 - Amendment to 10 CFR Part 9 - Waiver or Reduction of Fees Under the Freedom of Information Act (Consent Calendar Item)

The Commission, \* after determining that the item could not be affirmed, requested:

- 1) That Commission staff offices provide comments on the question of whether a requestor should be permitted to submit a request for waiver or reduction of fees within 30 days of the receipt of documents; (OGC/OPE) (SECY Suspense: 11/9/78)
- 2) That the item be scheduled for discussion in the near future. (SECY) (SECY Suspense: 11/13/78)

II SECY-78-366B - Edited Policy Statement From SECY-78-366 (Consent Calendar Item)

The Commission\*\*, by a vote of 4-0:

- 3) Approved the proposed Policy Statement as modified by the Secretary's memorandum of October 25, 1978 (attached) for publication in the Federal Register for a 60 day comment period. (NMSS) (SECY Suspense: 11/9/78)

- 6) That the procedures contained in the Policy Statement, as modified by public comment and staff analysis of those comments, be incorporated in the draft 10 CFR Part 60 expected to be issued in proposed form in early 1979. (NMSS/ELD)

III SECY-78-485 - Preliminary Statement on General Policy For Rulemaking to Improve Nuclear Power Plant Licensing (Consent Calendar Item)

The Commission, by a vote of 4-0\*\*\*:

- 7) Approved the proposed Interim Statement of General Policy, as modified by the staff (See 10/24/78 memo H. Denton to S. Chilk) and Commissioner comments, for publication in the Federal Register. Public comment on the Interim Statement will be invited for a 60 day period. (NRR) (SECY Suspense: 11/9/78)

- 8) That the proposed Interim Statement be circulated to the Commission before it is filed with the Office of the Federal Register. (NRR) (SECY Suspense: 11/6/78)
