SUBJECT: AP1000 - REQUESTS FOR WITHHOLDING INFORMATION FROM PUBLIC
DISCLOSURE (AW-04-1815)

Dear Mr. Sepp:

By letter dated April 19, 2004, from Mr. R. P. Vijuk, Manager, Passive Plant Engineering, AP600 & AP1000 Projects, Westinghouse Electric Company (Westinghouse), and supporting affidavit executed by Mr. James A. Gresham, Manager, Regulatory Compliance and Plant Licensing, Westinghouse, requested that portions of the transmitted AP1000 draft safety evaluation report (DSER) open item responses be withheld from public disclosure pursuant to Title 10 of the *Code of Federal Regulations* (10 CFR) Section 2.390. A nonproprietary copy of the March 15, 2004, transmission is available by contacting the Nuclear Regulatory Commission's (NRC's) Public Document Room and has been added to the Agencywide Documents Access and Management System Public Electronic Reading Room (ADAMS Accession No. ML041180198).

The transmittal stated that the submitted information should be considered exempt from mandatory public disclosure for the following reasons:

- (a) the information reveals the distinguishing aspects of a process (or component, structure, tool, method, etc.) where prevention of its use by any of Westinghouse's competitors without license from Westinghouse constitutes a competitive economic advantage over other companies;
- (b) the information consists of supporting data, including test data, relative to a process (or component, structure, tool, method, etc.), the application of which data secures a competitive economic advantage, e.g., by optimization or improved marketability;
- (c) use of the information by a competitor would reduce his expenditure of resources or improve his competitive position in the design, manufacture, shipment, installation, assurance of quality, or licensing a similar product.

In accordance with the requirements of 10 CFR 2.390, we have reviewed your application and material you designated as proprietary. On the basis of our review and your statements, we have decided that the information you marked as proprietary will be withheld from public disclosure. However, withholding from public inspection shall not affect the right, if any, of persons properly and directly concerned (including NRC employees or contractors who have a need to know) to inspect the information withheld from public disclosure. If the need arises, we

may send copies of this information to our consultants working in this area. We will, of course, ensure that the consultants have signed the appropriate agreements for handling proprietary information.
