The purpose of this modification is to provide incremental funding in the amount of \$12,278.01 to cover Invoice No. 70A, Part I, dated 4/8/04, which combines previously suspended amounts from invoices submitted for work performed by the contractor and fee withheld in accordance with FAR Clause 52.216-8. This modification will increase the obligated amount of the contract from \$575,899.00 to \$588,177.01. Accordingly, the contract is hereby modified as follows:

Under Subsection B.3, "CONSIDERATION AND OBLIGATION-COST PLUS FIXED FEE (JUN 1988), "paragraph (g) is deleted in its entirety and the following paragraph is substituted in lieu thereof:

"(g) The amount currently obligated by the Government with respect to this contract is \$588,177.01."

All other terms and conditions remain unchanged.
