The staff expects to complete its review by May 30, 2005, and estimates that the review will require approximately 1200 staff hours including project management time, and the estimated contractor cost of \$110,000 dollars. The review schedule milestones and estimated review costs were discussed and agreed upon in a telephone conference between George Stramback and myself on May 24, 2004.

Section 170.21 of Title 10 of the Code of Federal Regulations requires that LTRs are subject to fees based on the full cost of the review. You did not request a fee waiver; therefore, staff hours will be billed accordingly.
