On April 23, 2004, the U.S. Nuclear Regulatory Commission (USNRC) completed the onsite portion of an inspection at your Beaver Valley Power Station (Beaver Valley). The enclosed report documents the inspection findings, which were discussed on April 23, 2004, with Mr. James Lash, Plant Manager, Mr. Kenneth Halliday, Manager of Security, and other members of your staff.

This inspection examined activities conducted under your licenses as they relate to safety and compliance with the Commission's rules and regulations and with the conditions of your licenses. Within these areas, the inspectors reviewed selected procedures and records, observed activities, and interviewed personnel.
