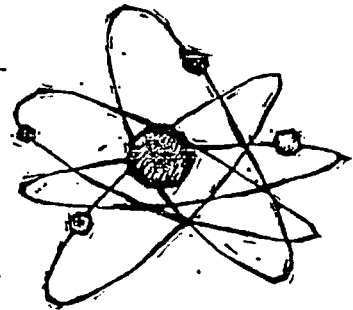



11. Radioactive material shall be used by, our under the supervision of, Jeffrey E. Wilson.
12. The Radiation Safety Officer for activities authorized by this license shall be Dixie Wells-O'Dou, RPPT.
13. This license does not authorize distribution of radioactive material.
14. Light sources containing radioactive material shall not be opened by the licensee.
15. The licensee shall conduct a physical inventory every 6 months to account for all sources and/or devices received and possessed under the license. Records of inventories shall be maintained for 2 years from the date of each inventory and shall include the quantities and kinds of radioactive material, manufacturer's name and model numbers, device serial numbers, location of the devices, and the date of the inventory.
16. Except as specifically provided otherwise in this license, the licensee shall conduct its program in accordance with the statements, representations, and procedures contained in the documents including any enclosures, listed below. NAC 459 shall govern unless the statements, representations and procedures in the licensee's application and correspondence are more restrictive than the regulations.
