

Comments on Notice for Opportunity to Comment on Model Safety Evaluation  
on Technical Specification Improvement to Eliminate Monthly Operating Report  
and Occupational Radiation Exposure Report

**Reference:** Federal Register Notice Vol. 69, No. 83, dated April 29, 2004,

The purpose of this letter is for the Nebraska Public Power District (NPPD) to indicate the results of it's review of the model safety evaluation (SE) and model no significant hazards consideration (NSHC), published by the U. S. Nuclear Regulatory Commission (NRC), in Federal Register Notice (FRN) Vol. 69, No. 83 (pages 23542-23546), dated April 29, 2004. The model SE and model NSHC were for a proposed revision to the Standard Technical Specifications (STS) to delete requirements for a Monthly Operating Report (MOR) and Occupational Radiation Exposure Report (ORER) in accordance with the NRC Consolidated Line Item Improvement Program (CLIP). The model SE and model NSHC were published for a 30-day review and comment period.

NPPD, the holder of the operating license for the Cooper Nuclear Station, appreciates the opportunity to provide comments on the model SE and NSHC published in the reference FRN. NPPD supports and agrees with the proposed deletion of the requirement for submittal of the MOR and ORER from the STS and expects to submit a license amendment request to adopt the subject changes after the CLIP is available for adoption by licensees. NPPD has no comment on the subject FRN.
