
NRC STAFF'S MOTION FOR

Counsel for Staff timely filed notices of appearance for the appropriate proceedings. Subsequently, the Atomic Safety and Licensing Board¹ for the proceedings



recognized that a number of issues raised by the Petitioners would be common to at least two and perhaps all three of the proceedings. See Atomic Safety and Licensing Board's March 22, 2004, Memorandum and Order (Scheduling Initial Prehearing Conference). To ensure consistent treatment of these common matters, the Licensing Board decided to consider all three proceedings together for the purpose of making important initial determinations about the standing of the various petitioners and the admissibility of any proposed contentions. *Id.* at 2. To facilitate consistent treatment of issues common to two or more proceedings, Staff has identified individual counsel who will represent the Staff on a given issue for each proceeding involving that issue. However, absent a notice of appearance in each of the relevant proceedings, that designated counsel would not be formally authorized to represent the Staff. Accordingly, the Staff hereby moves for leave to file notices of appearance for the undersigned attorneys.
