On April 30, 2004, the NRC completed an inspection at your North Anna Nuclear Power Station. Portions of the access authorization inspection were completed at the Dominion Energy Corporate Office from April 26-27, 2004. The enclosed report documents the inspection findings, which were discussed on April 30, 2004, with N. Lane and other members of your staff.

This inspection examined activities conducted under your licenses as they relate to safety and compliance with the Commission's rules and regulations and with the conditions of your licenses. Within these areas, the inspection consisted of selected examination of procedures and representative records, observations of activities, and interviews with personnel.

The material enclosed herewith contains Safeguards Information as defined by 10 CFR 73.21 and its disclosure to unauthorized individuals is prohibited by Section 147 of the Atomic Energy Act of 1954, as amended. Therefore, the material will not be placed in the Public Document Room.
