On February 20, 2004, the Nuclear Regulatory Commission (NRC) issued a First Revised Order Modifying Licenses in accordance with 10 CFR 2.202 that established interim inspection requirements for pressurized water reactor (PWR) vessel heads. This revised Order supersedes the original (Reference 3) NRC Order Modifying Licenses (Effective Immediately), dated February 11, 2003. Licensees are required by Section V of the First Revised Order to submit an answer in accordance with 10 CFR 2.202 within twenty (20) days of date of the Order.
