SUBJECT: PUBLIC MEETING SUMMARY ON THE REACTOR OVERSIGHT

PROCESS MONTHLY MEETING AND THE MITIGATING SYSTEMS

PERFORMANCE INDEX HELD ON JUNE 16 AND 17, 2004

On June 16 and 17, 2004, a Reactor Oversight Process (ROP) and Mitigating Systems Performance Index (MSPI) public meeting was held at the One White Flint North Building, Room 10B4. Attachment 1 contains the attendance lists for both meetings. Attachment 2 contains the agenda topics for both meetings.

During the June 16 ROP meeting, the staff discussed the status of its plans for a significance determination Process (SDP) timeliness workshop to be conducted on September 16 and 17, 2004. Industry led a discussion on a concern with consistency of interpretation of several Inspection Manual Chapter (IMC) 0612, "Power Reactor Inspection Reports," definitions involving inspection findings that were either self revealing, licensee-identified, or NRC identified. The staff led a discussion on the feasibility of improving the barrier integrity performance indicator. Industry agreed to work with its owner groups and to setting up ROP subgroups to further evaluate potential changes. Meeting participants also discussed status of the industry's review effort on Safety System Functional Failures (SSFFs) and the initiative to improve the Performance Indicator FAQ process.

During the June 17, 2004 MSPI meeting, the staff stated that it had not yet received all of the internal stakeholder responses to its May 25, 2004 memo that requested identification of critical issues that need to be resolved prior to replacement of the Safety System Unavailability (SSU) Performance Indicator (PI). The staff also stated that its goal was to have an agency position on these issues and how to proceed forward by the July 21, 2004 public meeting. Industry led a discussion of implementation issues if the decision was made to proceed forward with the MSPI. Near term items that would need to be accomplished soon after the decision is made
