AMENDED JOINT NOTICE OF CONTENTION UTAH K DEPOSITIONS

This Notice amends the Notice of Depositions filed May 21, 2004 by the Intervenor the State Utah. Due to the medical condition of one of the State's witnesses, the parties have agreed to hold the depositions during the week of June 21, 2004 in the Chicago area and in West Lafayette. Specifically, the probability depositions will be held near the NRC regional office, at the Hotel Wyndham, 3000 Warrenville Road, Lisle, Illinois. The depositions will be held on Monday, June 21, 2004 from noon until 7 p.m. and on Tuesday, June 22 from 9 a.m. until completed, or as the parties may otherwise agree. The depositions will be conducted in the following order: PFS witness Dr. Cornell, Utah witness Dr. Thorne, and Staff witness Dr. Damon.

The deposition location will then change to West Lafayette, Indiana, where Utah's structural experts, Drs. Sozen, Hoffmann, and Kilic will be deposed at the Hilton Garden Inn, 356 East State Street, West Lafayette. The depositions will take place from June 23 (9 a.m.) through June 25 continuing as needed until June 26, 2004, or as otherwise agreed by the parties.


