SUBJECT: MODIFICATION NO. 06 TO TASK ORDER NO. 15 ENTITLED "TECHNICAL ASSISTANCE FOR THE DEVELOPMENT OF AN ENVIRONMENTAL IMPACT STATEMENT COR THE LOUISIANA ENERGY SERVICES URANIUM ENRICHMENT FACILITY," UNDER CONTRACT NO. NRC-02-00-010

Dear Ms. Hwang:

The purpose of this modification is to 1) Exercise Optional Task Area 3, thereby increasing the task order ceiling amount by \$195,670.00, from \$907,279.33 to \$1,102,949.33 and 2) Obligate funding in the amount of \$407,279.00 from \$600,000.00 to \$1,007,279.00. Accordingly, the subject contract is hereby modified:

1. The second paragraph of the basic task order, second sentence, beginning with "The total" is deleted and substituted with the following in lieu thereof:

"The total cost ceiling is \$1,102,949.33 of which the sum of \$1,021,249.72 represents the reimbursable costs and the sum of \$81,669.61 represents the fixed fee."

2. The third paragraph of the basic task order, as modified in Modification No. 5, is deleted and substituted with the following in lieu thereof:

"Task Order No. 15 obligates funds in the amount of \$1,007,279.00, of which \$932,665.75 represents the reimbursable costs and \$74,613.25 represents the fixed fee."

The obligated amount shall, at no time, exceed the task order ceiling. When and if the amount(s) paid and payable to the Contractor hereunder equal the obligated amount, the Contractor shall not be obligated to continue performance of the work unless and until the Contracting Officer increases the amount obligated with respect to this task order. Any work undertaken by the Contractor in excess of the obligated amount specified above, is done so at the Contractor's own risk.




