In response to the April 29, 2003, Orders revising the design basis threat, you submitted revised physical security plans, safeguards contingency plans, and guard training and qualification plans, including an implementation schedule, for Indian Point Nuclear Generating Station, Units 2 and 3. The Nuclear Regulatory Commission staff is reviewing your April 29, 2003 (*sic*), submittal, as supplemented on June 1, 2004, and has determined that a request for additional information (RAI) is necessary in order to complete its evaluation based on its review of Sections 1 through 9 (except Section 9.4.1) of your physical security plan. Please respond to the enclosed RAI within 10 days from receipt of this letter.
