The purpose of this modification is to provide incremental funding in the amount of \$230,000 hereby increasing the obligated amount from \$500,000 to \$730,000. Accordingly, the contract is hereby modified as follows:

Under Section B.3, Consideration and Obligation—Cost Plus Fixed Fee, paragraph (c) and (d) are revised as follows:

- “(c) The amount currently obligated by the Government with respect to this contract is \$730,000, of which the sum of \$683,825.76 represents the estimated reimbursable costs, and \$46,174.24 represents the fixed fee.
- “(d) It is estimated that the amount currently allotted will cover performance through November 30, 2004.”

All other terms and conditions, including the ceiling amount of \$1,561,255.00, of the subject contract remain unchanged.

A summary of obligations, from the award date through the date of this modification, are provided below:

FY 03 Obligations:	\$300,000
FY 04 Obligations:	\$430,000
Cumulative:	\$730,000

This modification obligates FY 04 funds in the amount of \$230,000.
