Subject: Phase 2 LSS Requirements

During the June 14-15 TWG meeting we identified as an issue the number and locations of LSS access sites. Although our draft Phage 2 LSS Requirements document, in Table 9-1, gave a listing of public document room users and a listing of LSS participants, we recognized that the list did not include all potential parties. However, we were reluctant to go beyond the rule in naming access locations without LSSARP approval.

This issue was raised and discussed at the July 6-7, 1995 LSSARP meeting. The Panel Chairman asked that the TWG submit a proposed comprehensive list of LSS access sites and he would circulate that list to the Panel members for consideration and approval. Attached is a copy of Table 9-1 plus the list of additions I am proposing that we, the TWG, suggest based on the input we have gotten from members of the Panel. If you have other additions to suggest, please call me at (703) 488-2308.

We have been told that the Uranium Recovery Field Office in Denver no longer exists so we will remove it from Table 9-1.

We are on a tast track to iterate on the total package of the Phase 2 LSS Functional Requirements. Comments on the proposed Phase 2 LSS requirements are being collected from the Panel members with a due date of July 13. Hopefully we will have a package reflecting these comments in your hands no later than July 18. Your concurrence or comments will be needed by COB July 20 in order to meet the schedule the ARP Chairman has established for the Phase 2 requirements.
