Dan,

The DOE has taken the required actions to provide corrective action to the DOE LSN website and has reactivated the DOE LSN website as of 7/6/04.

The DOE has identified the technical issues that caused the problem, identified and corrected the documents on the website that were subject to the inadvertent release of privacy information, and has now reactivated the DOE LSN website. We expect to provide later today an updated clawback list with additional documents that need to be removed from the NRC index of the DOE LSN participant server documents prior to activating the NRC index of the DOE LSN document collection. We will also coordinate with you and your staff on the posting of a scanfile to identify the additional documents for deletion due to privacy concerns prior to activating the NRC index of the DOE LSN document collection.

We will also be discussing with you later today the process for removing images and text with privacy protected information discovered after reactivation of the DOE LSN participant website on 7/6/04. We believe such instances will be relatively rare, but we also believe it will be in the best interest of both the DOE and NRC to handle any such cases expeditiously.
