The Nuclear Regulatory Commission staff is reviewing your submission and has determined that a request for additional information (RAI) is necessary in order to complete its evaluation based on its review of Sections 1 through 9 of your physical security plan. Please respond to the enclosed RAI within 10 days from receipt of this letter.
