This modification increases the total funds obligated under this contract by \$100,000.00 from \$839,000.00 to \$939,000.00. Therefore, paragraphs (c) and (d) of Section B.3 CONSIDERATION AND OBLIGATION are revised to read as follows: "(c) The amount currently obligated by the Government with respect to this contract is \$939,000.00, of which \$901,440.00 represents the estimated reimbursable costs, of which \$37,560.00 represents the fixed fee."

"(d) It is estimated that the amount currently allotted will cover performance through December 31, 2004."
