On July 13, 2004, the Nuclear Regulatory Commission (NRC) held a public meeting at the Oak Harbor High School in Oak Harbor, Ohio. The meeting was between the NRC Davis-Besse Oversight Panel and FirstEnergy Nuclear Operating Company (FENOC) to discuss licensee performance and planned activities as part of the Manual Chapter 0350 process at the Davis-Besse Nuclear Power Station. The transcript of the meeting will be made publicly available in ADAMS and on the NRC's Davis-Besse web page when it is available. Agenda topics included plant performance, discussion of the status of the licensee's improvement initiatives, performance monitoring and independent assessments; and a discussion of site assessment, mid-cycle outage and oversight perspective.
