By letter dated April 29, 2004, as supplemented on May 18, 2004, Carolina Power and Light Company, now doing business as Progress Energy Carolinas, Inc. (PEC), responded to the April 29, 2003, NRC security-related Order EA-03-086 for the H. B. Robinson Steam Electric Plant (HBRSEP), Unit No. 2. On July 9, 2004, the NRC issued a Request for Additional Information (RAI) to PEC on the HBRSEP, Unit No. 2, Guard Training and Qualification Plan. PEC received that letter on July 13, 2004.
