






## NRC Oversight Activities

## **Baseline Inspection Program**

- Gathers objective evidence of plant safety
- Conducted at all plants
- Focuses on safety-significant:
  - systems
  - components
  - activities
  - events

- Inspection reports describe significant findings and non-compliance
- Inspection reports are publicly accessible

# Event Follow-up and Supplemental Inspections

- Review events for significance




