The purpose of this modification is to: 1) Incorporate a within scope change to the delivery order for the estimated cost to complete Task 2 and required modifications to Task 3, in accordance with the contractor's proposals dated March 11, 2004 and March 24, 2004, as revised on April 20, 2004, which are incorporated herein by reference, 2) Increase the ceiling amount in the delivery order by \$78,221.84 from \$2,921,640.69 to \$2,999,862.43; and 3) Increase the amount funded in the delivery order by \$148,903.00 from \$2,748,413.45 to \$2,897,316.45. Accordingly, the delivery order is hereby modified:

1) Section D.10, CONSIDERATION AND OBLIGATION, first paragraph, as modified in Modification No. 5, is deleted and substituted with the following in lieu thereof:

"The total estimated amount (ceiling) of this order is \$2,999,862.43. The total estimated amount for Task 2 is \$518,440.27 and the total estimated amount of Task 3 is \$1,017,208.88. The total estimated amount for Optional Task 3A is \$121,539.66 and Optional Task 3B is \$113,378.34. The NRC reserves the right to exercise the options at anytime during contract performance provided written notification to the contractor is within 15 days of its intent to exercise the optional tasks. Should the NRC exercise the optional tasks, the delivery order ceiling will be increased to \$3,234,780.43"

2) Section D.10, CONSIDERATION AND OBLIGATION, second paragraph, first sentence, as modified in Modification No. 6, is deleted and substituted with the following in lieu thereof:

"The amount presently obligated with respect to this order is \$2,897,316.45."
