
14. DESCRIPTION OF AMENDMENT/MODIFICATION (Organized by UCF section headings, including solicitation/contract subject matter where feasible.)

A. The purpose of this modification is to exercise Option Period 1 (October 1, 2004 through September 30, 2005) at an estimated total amount of \$31,900.

B As a result of this modification, the total amount obligated and estimated contract amount is increased by \$31,900, from \$30,800 to \$62,700.
