Eddie - I have reviewed the draft TOC you sent me last month and compared it to the applicable review sections identified in RS-002. I had some questions regarding the differences. First, I noted that the following sections were identified in your TOC but are not listed as applicable ESP sections in RS-002. Can you please confirm that you do intend to submit ESP information for these sections for NRC review so that we can ensure we have review staff assigned to handle them?

#### Site Safety Analysis Report

##### 2.4.8 Cooling Water Canals and Reservoirs

[erg] This section is currently included in the draft SSAR. It addresses:  
a) the cooling lake and its associated dam, b) the UHS pond and its dam within the lake, and c) the station discharge flume.

##### 2.4.10 Flooding Protection Requirements

[erg] This section is currently included in the draft SSAR but mostly for a placeholder as it really only says this will be addressed at COL.

##### 2.4.14 Technical Specification and Emergency Operation Requirements

[erg] This section is currently included in the draft SSAR. It essentially says we don't think we will need any.

##### 2.5.6 Embankments and Dams

[erg] This section is currently included in the draft SSAR. It addresses: a) the cooling lake dam, b) the UHS dam within the lake, and c) seismically induced floods and water waves.

Also, the following sections appeared to be missing from your draft TOC for the SSAR:

### 3.5.1.6, Aircraft Hazards

[erg] This information requested for this RS-002 section is currently included in associated draft SSAR section 2.2.2.5 rather than a separate section 3.5.1.6.

### 13.6 Physical Security

[erg] This topic is currently addressed in draft SSAR section 3.4.1.6. None of the information is considered to be "safeguards information."

These items need to be addressed in your application. For security, the application needs to address the items identified in the NRC's May 6, 2003 letter to Exelon on this subject. Please let me if Exelon plans to address these items.
