

The purpose of this modification is to exercise CLINs 0010 and 0011 for Option Year 3,
and to allot incremental fund of \$328,720 to this contract.

1. CLINs 0010 and 0011 for Option Year 3 are hereby exercised.
2. As a result, the estimated cost and fixed fee of the contract are hereby increased as follows:

4. As a result of #2 and #3 above, Section B.4 is replaced with the following revised Section B.4 CONSIDERATION AND OBLIGATION - COST PLUS FIXED FEE (JUN 1988)

B.4 CONSIDERATION AND OBLIGATION--COST PLUS FIXED FEE
(JUN 1988) ALTERNATE I (JUN 1991)

This clause applies only to CLINs 1, 2, 4, 5, 7, 8, 10, 11, 13, and 14.

(a) The total estimated cost to the Government for full performance of this contract is \$3,722,975, of which the sum of \$3,459,981 represents the estimated reimbursable costs, and of which \$262,994 represents the fixed fee.

(b) There shall be no adjustment in the amount of the Contractor's fixed fee by reason of differences between any estimate of cost for performance of the work under this contract and the actual cost for performance of that work.

(c) The amount currently obligated by the Government with respect to this contract is \$2,852,924. As of invoice no. 31 cost recovery in amount of \$282,400 has been applied to the cost appropriation of this contract. Therefore, the total funding obligated by the NRC and applied to the contract through cost recovery is \$3,135,324. Of this amount, the sum of \$282,400 was applied to the estimated costs thru cost recovery and \$2,631,442 represents the obligated funds earmarked for reimbursement of costs, and \$221,482 represents the funds earmarked for the fixed fee.

(d) It is estimated that the amount currently allotted will cover performance through December 31, 2004.

5. Section F.6 is replaced with following revised Section F.6:

F.6 DURATION OF CONTRACT PERIOD (MAR 1987)
ALTERNATE 4 (JUN 1988)

The period of performance CLINs 1, 2, 4, 5, 7, 8, 10 & 11 commenced on December 4, 2001 and will expire on December 3, 2005. The ordering period for CLINs 3, 6, 9, 12 and 15 commenced on December 4, 2001 and will expire on December 3, 2006. Any orders issued during this period shall be completed within the time specified in the order, unless otherwise specified herein. (See 52.216-18 - Ordering.) The term of this contract may be extended at the option of the Government for an additional year for CLINs 13 and 14.

6. All other terms and conditions remain unchanged.
