- SUBJECT: SUMMARY OF JULY 30, 2004 MEETING WITH NUCLEAR ENERGY INSTITUTE (NEI) AND MATERIALS RELIABILITY PROGRAM ON BUTT WELD SAFETY ASSESSMENT

On July 30, 2004, Nuclear Regulatory Commission (NRC) staff met with representatives of the Nuclear Energy Institute, the Electrical Power Research Institute (EPRI) Materials Reliability Program (MRP) and industry in a public meeting at NRC headquarters in Rockville, Maryland. A list of meeting attendees is provided in Attachment 1 of this memorandum. At this meeting, industry discussed its Safety Assessment for Alloy 82/182 Butt Welds including a review of actions recommended by MRP for industry and results of field inspections. Industry presented information in MRP-113 which is a summary document for the MRP's Butt Weld Safety Assessment. The industry presentation included an overview of the content of MRP-113, a summary of butt weld locations, a description of field experience, safety assessment calculations, safety assessment conclusions, leak before break strategy, and status of development of the butt weld inspection and examination guidelines. Detailed information on the industry presentation is available in Attachment 2 to this memorandum (ADAMS Accession No. ML042160480) which is the viewgraphs presented by industry at the meeting.

Industry has submitted MRP-113 to NRC for information and will submit the supporting reports upon request.

Notable conclusions of the MRP regarding Alloy 600 butt welds were that there was not an immediate safety concern, that "Needed" actions for visual inspection of Alloy 82/182 butt welds had been issued under NEI 03-08 ("Needed" is an NEI 03-08 category), and that inspection and examination (I&E) guidelines were being developed. Industry plans to meet with NRC to review their approach and obtain feedback in the Fall of 2004, and that NEI\MRP plan to issue "Mandatory" requirements under NEI 03-08 when the I&E guidelines were ready.

The NRC staff asked clarifying questions throughout the presentation but did not comment on the conclusions presented by the MRP as the staff had not reviewed the information in detail.
