Safeguards Condition SG-2.1 has been revised and reads as follows:

SG-2.1        The licensee shall follow the physical protection plan entitled, "Physical Security Plan," Revision 31, dated April 30, 2004, and as it may be further revised in accordance with the provisions of 10 CFR 73.32(e).

All other conditions of this license shall remain the same.
