The purpose of this letter is to provide the Physical Security Plan which also includes the Training and Qualification Plan and the Safeguards Contingency Plan. This plan supercedes TVA's proposed Physical Security Plan dated April 29, 2004, pursuant to the subject Order and includes proposed changes in response to NRC's requests for additional information dated July 7, July 14, July 28, August 12, and September 1, 2004.

In TVA's letter to NRC dated September 1, 2004, TVA stated that the force-on-force exercises shall follow the guidance of NEI 03-09 (Revision 1) January 2004. As stated in the supplemental Physical Security Plans TVA will follow the guidance of NEI 03-09 (Revision 2) April 2004. This response contains Safeguards Information as defined in 10 CFR 73.21. TVA therefore, requests that the Enclosure be withheld from public disclosure.
