Entergy's above referenced letters CNRO-2004-00042, 00044, 00046, 00048, 00052 and 00058 (references 1-6) provided Entergy's combined responses to NRC's requests for additional information (RAIs) for River Bend Station's April 29, 2004, Security Plan submittal (reference 7) required by Order EA-03-086. As committed in each of those submittals, this letter provides the revised Security Plan documents on CD ROM that incorporate the required RAI responses by September 9, 2004.

In order to standardize our fleet approach with the NRC-approved industry approach, Entergy's responses to Order EA-03-086 and RAIs were strictly based on NEI-03-12, "Template for the Security Plan, Training and Qualification Plan, Safeguards Contingency Plan" Revision 1 and subsequent guidance provided by NEI and approved by the Staff. Changes were made during this update to sections 9.4.1 and 10.1 as discussed with M. Chernoff on August 31, 2004, and September 1, 2004, and other editorial corrections were made where appropriate that were consistent with NRC guidance dated August 12, 2004.
