

SUMMARY OF OPERATING EXPERIENCES

Highlights

Vermont Yankee operated at 99.8% of rated thermal power for the month. Gross electrical generation was 388,220 MWh or 95.5% design electrical capacity.

Operating Summary

The following is a chronological description of plant operations including other pertinent items of interest for the month:

At the beginning of the reporting period the plant was operating at 98.2% of rated thermal power.

There were no items of interest to report for this month.

At the end of the reporting period the plant was operating at 99.9% of rated thermal power.
