The purpose of this modification is to provide incremental funding in the amount of \$27,214 for NSIR. Accordingly, the contract is hereby modified as follows:

Under Section B.2, Consideration and Obligation-Delivery Orders (JUN 1989), the first sentence of paragraph (a) is revised as follows:

"(a) The amount presently obligated with respect to this contract is \$79,413.92."
