**TECHNICAL CONFERENCE FORUM - REQUEST FOR COMMENTS - PLANNED SOLICITATION OF PUBLIC COMMENT ON DRAFT RULE WORDING: REVISION OF CERTAIN PROVISIONS OF 10 CFR PARTS 2, 30, 40, 50, 70, 73, AND 76 RELATED TO PROTECTION OF SAFEGUARDS INFORMATION (STP-04-074)**

We have posted the draft *Federal Register* notice (FRN), including draft rule language for possible changes to 10 CFR Parts 2, 30, 40, 50, 70, 73, and 76 Related to Protection of Safeguards Information. The U.S. Nuclear Regulatory Commission (NRC) is proposing to amend its regulations for the protection of Safeguards Information to be consistent with recent Commission practices reflected in Orders and Threat Advisories issued since September 11, 2001, and to provide the flexibility afforded the Commission by the Atomic Energy Act of 1954, as amended (Act), for the protection of such information. The requirements imposed by the Orders have added licensees, information, and materials not currently specified in the regulations, but which are within the scope of the Act. As part of NRC's efforts to engage stakeholders early in the rulemaking process, the NRC staff plans to make public this draft FRN in advance of a proposed rule through a *Federal Register* notice and related posting on the NRC website that will provide a description of the changes and the draft rule language currently being considered by the NRC staff. Prior to posting the draft FRN on the NRC public website, we are providing the Agreement States an opportunity to see the draft FRN. We will inform you when the draft FRN is posted on the NRC public website and any revisions to the draft FRN can be viewed there. We ask that you provide comments\* within 30 days from the date of this letter directly to: Ms. Marjorie Rothschild, 301-415-1633; email: [MUR@NRC.GOV](mailto:MUR@NRC.GOV).

The draft FRN is predecisional and is available only at the Agreement State area of the NRC Technical Conference Forum: <http://techconf.llnl.gov/cgi-states/topics>. The draft proposed rule language is marked: "PREDECISIONAL DRAFT INFORMATION - FEDERALLY PROTECTED - NOT FOR PUBLIC DISCLOSURE."

Due to its predecisional nature, this draft FRN, pending its posting on the NRC public website, is exempt from public disclosure under NRC rules. Therefore, we request that you limit distribution to your staff and not release the draft FRN publicly. If this draft FRN is released, please inform me or
