The purpose of this modification is to provide incremental funding in the amount of \$47,000.00, thereby, increasing the obligated amount from \$567,000.00, to \$614,000.00. Accordingly, the delivery order is modified as follows:

- (1) Under **Section A.5, Consideration and Obligation**, the first sentence of Paragraph (b) is deleted entirely and replaced with the following:

“(b) The amount presently obligated with respect to this delivery order is \$614,000.00.”

As a result of this modification, incremental funding in the amount of \$47,000.00 is being obligated under this order. The obligated amount shall, at no time, exceed the deliver order ceiling. When and if the amount(s) paid and payable to the Contractor hereunder shall equal the obligated amount, the Contractor shall not be obligated to continue performance of the work unless and until the Contracting Officer shall increase the amount obligated with respect to this task order. Any work undertaken by the Contractor in excess of the obligated amount specified above is done so at the Contractor's sole risk.

All other terms and conditions of this order, including the ceiling amount of \$614,868.16 remain unchanged.

A summary of obligations, from the award date through the date of this action, is given below:
