This modification increases the total funds obligated under this contract by \$94,400.00 from \$939,000.00 to \$1,033,400.00. Therefore, paragraphs (c) and (d) of Section B.3 CONSIDERATION AND OBLIGATION are revised to read as follows: "(c) The amount currently obligated by the Government with respect to this contract is \$1,033,400.00, of which \$992,064.00 represents the estimated reimbursable costs, and \$41,336.00 represents the fixed fee."
"(d) It is estimated that the amount currently allotted will cover performance through April 30, 2005."
