Dear Mr. Weisenbeck:

This Modification No. 1 raises the task order ceiling by \$99,935.20 to provide for additional work as described in the attached Statement of Work for Modification No. 1 and the contractor's September 28, 2004 proposal (reference the contractor's 9/29/04 E-mail). This Modification No. 1 also establishes estimated cost ceilings for the acquisition of replacement parts, maintenance, and adaptive maintenance efforts. Accordingly, the task order ceiling is increased from \$49,060.00 by \$99,935.20 to \$148,995.20. In addition, the period of performance is hereby extended to October 17, 2005.

The total task order ceiling includes the following cost ceilings:

Replacement Parts	\$20,000.00
Maintenance	\$49,586.97
Adaptive Maintenance	\$20,940.00

Additional funds are hereby obligated in the amount of \$99,935.20, thereby raising the total obligated amount from \$49,060.00 to \$148,995.20. The obligated amount shall, at no time, exceed the task order cost ceiling \$148,995.20. When and if the amount(s) paid and payable to the Contractor hereunder shall equal the obligated amount, the Contractor shall not be obligated to continue performance of the work unless and until the Contracting Officer shall increase the amount obligated with respect to this task order. Any work undertaken by the Contractor in excess of the obligated amount specified above is done so at the Contractor's risk.


