SUBJECT: MODIFICATION NO. 34 TO INTERAGENCY AGREEMENT NO.
NRC-09-93-233 ENTITLED, "NUCLEAR SAFETY ATTACHE POSITION
AT U.S. MISSION IN VIENNA"

Dear Mr. Simpson:

Pursuant to the Economy Act of 1932, as amended, the Nuclear Regulatory Commission (NRC) and the Department of State (DOS) desire to continue an agreement whereby DOS will provide administrative support to the NRC in maintaining the position of Nuclear Safety Attache assigned to the U.S. Mission as described in the enclosed Memorandum of Understanding.

Accordingly, upon your agreement as provided below, the terms and conditions of this Interagency Agreement are as follows:

Article I - Period of Performance

The period of performance of this Agreement shall be from August 1, 1993, through September 30, 2005. The period of performance may be extended by mutual agreement of both parties. Those changes shall be incorporated into this Agreement by the issuance of modifications to this Agreement.

Article III - Funding Limitations

Funding for this Interagency Agreement is subject to availability of FY2005 funds. Upon receipt of these funds, a modification will be issued to this agreement.

The total estimated amount of this agreement for the one year period of performance (October 1, 2004 through September 30, 2005) is \$360,000.

Of that amount, the allowable expenses for FY 2005 shall not exceed \$360,000 as follows:

1. Provides for Attache apartment including utilities, elevator, garage, maintenance/operating expense and ICASS overhead. Also provides for employee benefits and post allowance (comparable to locality pay) [Job Code L1445, BOC 1210]:



MEMORANDUM OF UNDERSTANDING
BETWEEN
THE DEPARTMENT OF STATE
AND
THE NUCLEAR REGULATORY COMMISSION

The Nuclear Regulatory Commission's (NRC) position of Nuclear Safety Attache will be assigned to the U.S. Mission/Department of State (DOS) under the terms of this Memorandum of Understanding. Prior to the Attache's departure to the U.S. Mission, the NRC is responsible for obtaining the appropriate security clearance and a pre-appointment drug clearance and for advising the employee of the terms of this agreement.

The Nuclear Regulatory Commission will provide the following:

The NRC, the U.S. Mission, and the DOS agrees to continue the position of the Nuclear Safety Attache for an additional twelve (12) months. Prior to the end of the 12 month extended period, the NRC, the U.S. Mission, and the DOS will review the desirability of continuing the position. Financial reimbursement to DOS for FY 2005 is described in Attachment A.

Costs and billing information will be provided via interagency agreement document, which will serve as an obligation document.

Reimbursement to DOS or pay direct for all allowances within the scope of NRC's authority (see Attachment A), including, but not limited to housing, other post allowances, emergency visitation travel, field travel and temporary quarters. NRC will directly reimburse the employee for all allowable costs associated with Change of Station travel.

Telegraphic Authority to pay, which includes necessary salary and benefit information.

NRC approved cost-of-living increases on the same schedule as other NRC employees.

Limited voucher certifying authority letter authorizing DOS (American Embassy, Vienna) use of NRC fund citation.

The Department of State will provide the following:

Administrative reporting (leave administration, time and attendance, and travel authorizations, etc.)

DOS will ask the passport office to issue a diplomatic passport.

Salary and salary-associated benefits (to be paid by DOS through its Charleston, South Carolina Office, with vouchering authority to charge NRC appropriations directly).


Preparation of the Nuclear Safety Attache's performance appraisal for transmittal to the Director, Office of International Programs, NRC.
