This modification confirms the verbal authorization provided to Project Performance Corporation on 6/1/04, to begin work, effective 6/2/04, with a temporary ceiling of \$100,000.00. The purpose of this modification is to: (1) exercise the Optional Task, Task 2, Implementation Support, thereby increasing the delivery order ceiling amount by \$177,439.16 from \$427,087.00 to \$614,868.16, and obligating incremental funds in the amount of \$100,000.00, which was provided as the temporary ceiling under the verbal authority, (2) change the NRC Technical Monitor, and (3) extend the period of performance through 12/31/2004. The work performed under Task 2 shall be in accordance with the Attached Statement of Work and the Contractor's 5/10/04 proposal, which is hereby incorporated by reference. Accordingly, the delivery order is modified as follows:

- (1) Under **Section A.4.3, Schedule, CLIN 0002 - Provide Implementation Support, As Requested (OPTION)** is deleted entirely and replaced with the following:

"(a) The total estimated amount of this delivery order (ceiling) for the products/services ordered, delivered, and accepted under this delivery order is \$614,868.16.

(b)The amount presently obligated with respect to this delivery order is \$513,000.00."

- (4) **Section A.6, Period of Performance** is deleted entirely and replaced with the following:

"This order shall be effective from September 8, 2003, through December 31, 2004."

- (5) Under Section B.VIII.B., Technical Project Manager, the name, address, telephone number, and e-mail address are deleted entirely and replaced with the following:

As a result of this modification, the delivery order ceiling amount is increased by \$177,439.16, from 437,429.00 to \$614,868.16. Funds in the amount of \$100,000.00, **inclusive of the verbal ceiling** (provided on 6/1/04) are being obligated under this order. The obligated amount shall, at no time, exceed the deliver order ceiling. When and if the amount(s) paid and payable to the Contractor hereunder shall equal the obligated amount, the Contractor shall not be obligated to continue performance of the work unless and until the Contracting Officer shall increase the amount obligated with respect to this task order. Any work undertaken by the Contractor in excess of the obligated amount specified above is done so at the Contractor's sole risk.

All other terms and conditions of this order remain unchanged.
