Subsequent to the submittal of our Supplemental Response, we received several Requests for Additional Information (RAIs) from the NRC. We responded to those RAIs within the time frames specified. Subsequent to the submittal of our Amended Supplemental Response, we received additional RAIs. We responded to those RAIs within the time frames specified via References (c) and (d).
