The NRC staff expects to issue requests for additional information by January 28, 2005, and complete its review by September 30, 2005, and estimates that the review will require approximately 320 staff hours including project management time. The review schedule milestones and estimated review costs were discussed and agreed upon in a telephone conference between Gayle Elliot and myself on October 18, 2004.
