SUBJECT: REQUEST FOR WITHHOLDING INFORMATION FROM PUBLIC DISCLOSURE,  
TRIJICON, INC., MODEL AN\PSQ-18A LUMINOUS GUN SIGHT

Dear Mr. Schick,

Trijicon, Inc. submitted a safety evaluation application for the Model AN\PSQ-18A luminous gun sight, dated February 18, 2004, and an affidavit dated July 27, 2004. Trijicon requested that eight engineering drawings, drawing numbers DNS-462, DNS-465, DNS-181, DNS-200, IMS2489, IMS2585, T 4964, and T 4367-1 be withheld from public disclosure pursuant to 10 CFR 2.390.

Trijicon stated that the drawings contain trade secrets or privileged or confidential commercial or financial information, and such information:

- has been held in confidence by the Corporation.
- is of the type that is customarily and rationally held in confidence by the Corporation.
- was transmitted to and, to the knowledge of Trijicon, received by the Commission in confidence.
- is not available in public sources.
- is of the type and nature that, if disclosed publicly, is likely to cause substantial harm to the competitive position of the Corporation.

We have reviewed Trijicon's application and the engineering drawings in accordance with the requirements of 10 CFR 2.390 and, on the basis of Trijicon's statements, have determined that drawing numbers DNS-462, DNS-465, DNS-181, DNS-200, IMS2489, IMS2585 sought to be withheld contain proprietary commercial information, therefore, will be withheld from public disclosure pursuant to 10 CFR 2.390(b)(5) and Section 103(b) of the Atomic Energy Act of 1954, as amended. However, drawing numbers T 4964 and T 4367-1 contain information already made publicly available under the sealed source registration certificate number NR-446-S-102-S, therefore, will not be withheld from public disclosure.

Withholding from public inspection shall not affect the right, if any, of persons properly and directly concerned to inspect the documents. If the need arises, we may send copies of this information to our consultants working in this area. We will, of course, ensure that the consultants have signed the appropriate agreements for handling proprietary information.

If the basis for withholding this information from public inspection should change in the future such that the information could then be made available for public inspection, you should promptly notify the NRC. You also should understand that the NRC may have cause to review this determination in the future, for example, if the scope of a Freedom of Information Act request includes your information. In all review situations, if the NRC makes a determination adverse to the above, you will be notified in advance of any public disclosure.
