SUBJECT: REQUEST FOR ADDITIONAL INFORMATION CONCERNING APPLICATION

FOR RENEWAL OF LICENSE, CONTROL NO. 135640

## Dear Dr. Arnold:

This is in reference to the letter dated November 8, 2004, submitted by Terry Day of your staff, in response to our letter dated October 30, 2004 regarding renewal of Nuclear Regulatory Commission License No. 37-28333-01. In order to continue our review, we need the following additional information:

- 1. For the facility diagrams in Attachments 3B, 3D, 3E, 3H, and 3L of your letter, please confirm that the hot lab areas contain a shielded area for preparation and storage of radiopharmaceuticals (e.g., lead glass L-block, lead cave, etc.). Also confirm that radioactive waste will be stored in a lead-lined waste container in the hot lab area.
- 2. Please provide a description of the radiation monitoring instruments that will be used at each facility to perform radiation level detection, measurement, and contamination surveys.
- 3. Attachment 3 of your letter stated that no materials are currently used at your facility at 15 N. Presidential Blvd., Suite 100, Bala Cynwyd, Pennsylvania. A facility diagram was not provided. We will remove this address as a location of use on your license. If you have used licensed material at this location in the past, please provide a closeout survey.
- 4. Your current license lists the address of your Absecon, New Jersey facility as 310 S. Chris Gaupp Drive, Suite 18. Your letter stated that the address is Suite 1. Please provide the correct suite number.
- 5. Your current license lists the address of your Princeton, New Jersey facility as 1000 Herrontown Road. Attachment 3 of your letter listed the address as 181 North Harrison Street, however Attachment 3G stated the 1000 Herrontown Road address. Please confirm the correct address.
- 6. It appears that Attachments 3H and 3L of your letter are reversed for your two Cape May Court House, New Jersey facilities. Please clarify.

7. NRC requires license applications to be signed by the owner or a member of senior management. The letter dated November 8, 2004 was signed by your staff member, Terry Day. Please confirm that you concur with all statements made in this letter. Please ensure that you review and sign all future license amendment or renewal correspondence.

Please note that on October 25, 2004, the NRC suspended public access to ADAMS, and initiated an additional security review of publicly available documents to ensure that potentially sensitive information is removed from the ADAMS database accessible through the NRC's web site.
